Signing below authorizes on-site monitoring of your Cascade Shores home for obvious problems such as storm damage, running water, break-in, unlocked or open doors and windows. The home monitoring inspector normally walks around the perimeter of your house. Under difficult weather conditions or if there are access problems, they will do the best they can.

Our volunteer inspectors, Clay Glanz and Leslie Grassi, live in Cascade Shores, know the area, and report to the board. If they are unavailable, the service will be performed by a substitute, most likely a board member. Our inspector is unpaid but is reimbursed for vehicle expenses. HOME MONITORING SERVICE INCLUDES ONE OR MORE of the following:

- 1. **Vacation Monitoring:** One (1) Time per week of absence when you notify Clay and Leslie at least two weeks in advance of your departure.
- 2. **Unoccupied Home Monitoring:** One (1) time per week for members who have homes that are unoccupied most of the time.
