President's Message

The Cascade Shores Homeowners Association continues to do well. We have 156 members, slightly below last year's 166. However, we often get some additional members as the cold weather sets in and people see how much money they can save on their propane bill, currently about 47% from non-member prices. Membership is very important, as maintaining and improving the Lost Mine Lake facility requires a significant cash flow.

Kent Rees, Doug Gloff and I had meetings with the Consolidated Fire Chief concerning having a fire alarm system. Other homeowner's associations have been doing so as well. We were recently informed that the police and fire departments involved have decided upon a fire alarm system. Each patrol car will have an additional European style siren so the specific neighborhood involved can be alerted instead of a broad area, generalized alarm. The details will be publicized when the system is functional, which should be before the next fire season. The present Code Red system will continue.

At the request of several members I discussed the problem of people speeding in Cascade Shores with the CHP. They promised to address the problem. If there are continuing complaints, I will meet with them again.

Vice-President Doug Gloff and Andrew Guevel have spent a great many hours maintaining and improving our Lost Mine Lake property. We owe them a huge debt of gratitude. The details of what has been done will be in Doug's report.

Another person to whom we owe a debt of thanks is Jim LeFrancois. He has done a lot of backhoe work at Lost Mine Lake, thus saving the association a significant amount of money.

Many of you have done a great job of improving the fire safety of your property. We heartily thank you.

We recently had a "Thank You" barbecue for those members who contributed time and or money to the association during this fiscal year above and beyond the membership fees. We tried to invite all who qualified. If we missed anybody, we apologize for our error. Thank you to Cheryl Lester for organizing this year's event and Greg Lester for doing a fantastic job manning the barbecue.

Our annual Christmas party is scheduled for December 7th at the The Northern Queen Station. Further details will be published in an e-mail notice when we are closer to the date. We hope to see a good turnout again this year. All of those who attend the Christmas party seem to have a really good time.

We have 3 vacant positions on the Board of Directors. If any of you are interested in taking a more active role in the organization, please talk with me or another Board member. You do not need to wait for the annual election, as we can always make interim appointments.

Siren System for Nevada County

In the wake of the Camp fire, there has been huge interest in developing an audible wildfire warning/evacuation system for our vulnerable neighborhoods. In Paradise, the Code Red system let down many people who never got the evacuation call. The recent, first-ever test of Nevada County's system found thousands of useless phone numbers. We know that only about half of our County residents have bothered to sign-up for Code Red which means NO EVACUATION CALL if reliant on unregistered cell phones. AT&T land lines are automatically connected to Code Red, but more and more people are dropping those and going to cell phones exclusively.

Last May, your CSHA leadership and representatives from the Firewise Committee met with Chief Turner of Consolidated Fire to recommend the consideration of an audible system to supplement Code Red. In June, the Cascade Shores Firewise Committee made a similar recommendation to the Coalition of Firewise Communities representing all the Firewise groups in Nevada County. A consensus of representatives at that meeting agreed that the status quo was inadequate and that Nevada County needed to "do something" toward developing an audible system that would be an addition to Code Red.

We think that we have been heard and taken seriously. As per the front page story in The Union on September 16, a second audible alarm system is being installed on Nevada County sheriff cars and on those belonging to Nevada City and Grass Valley Police Departments. This is a 2-tone alarm similar to audible emergency sirens used in European ambulances. It's reserved FOR EVACUATION EVENTS ONLY. This new alarm is much different from the whining sirens for other emergencies used in American police cars, so the distinction will be clear. In a wildfire situation, police cars can be positioned in targeted neighborhoods and use the new signal to tell people to evacuate. If cell phones are down or not being used, this alarm will be loud enough to catch your attention. It should be something everyone can hear. This is NOT THE SAME as giving an advance warning, but it's nevertheless a move in the right direction to save lives and organize a safer evacuation process.

Our recommendation: Register all phones with Code Red at *mynevadacounty.com* and keep them powered up and handy during fire season. Think of Code Red as your

first line of defense and the new system as a back-up, "just in case" evacuation alarm. Because there is NO GUARANTEE of evacuation calls/alarms, stay vigilant and prepared to leave as quickly as possible especially during Red Flag events.

Stay tuned for further information and community education in regard to the new system. We thank our County safety officials and the Office of Emergency Services for taking this step to improve fire safety.

On behalf of the Board, I would like to thank the HOA members who generously donated time and funds to allow the completion of major projects at LML.

The aeration project, which was started last year, has been completed. This has resulted in a substantial reduction of bladder wort and improved the water clarity.

Overhead lighting has been added to the lawn and parking lot. This has been done to improve safety and security. It also allows extended hours for rentals.

The replacement of the 2 overflow pipes is scheduled for October. They are failing and are being replaced by larger diameter pipes to improve flow.

The yearly cleaning of the drainage ditch will be completed this month.

Andrew Guevel and I are constantly working to enhance the LML facility and to provide an enjoyable experience when visiting the lake.

Security Patrol

It has been a full year now that I have been providing security patrol service to CSHA members who purchased the enhanced membership, after taking over from Tom Bennett.

As the patrol person, I check on homes weekly to make sure that doors are secure and everything looks OK. I typically walk around the entire house and onto decks to make sure there aren't any open windows or doors. When I see something out of the ordinary, I contact the home owner. If necessary, I would also contact law enforcement

So far in my rounds, I have found open doors, and storm damage with trees and lines down. Luckily I have not had any issues with trespassers or vandalism. If I find something of note, I communicate immediately via phone or e-mail.

Please remember that security patrol is not law enforcement.

If you have issues or concerns like people stealing mail out of our mailboxes, off-road vehicles being driven on our residential streets, offensive noise levels from unruly neighbors, alarms going off on unoccupied homes, suspicious activity occurring at a neighboring house, dogs not on leashes, or excessive speeding on our streets, please contact the appropriate Nevada County authorities. They have the legal authority to respond and act. Their phone numbers are:

If you are interested in having security patrol visit your house weekly, check out the CSHA website: www. cascadeshores.org and click on Security Patrol on the left side of the screen. The "Authorization for Security Patrol Inspections" form is located there. Enhanced Membership is an affordable \$175 a year, which includes a weekly inspection of your home (April 1 to March 31). Here is a quick summary of what CSHA Security Patrol provides for "Enhanced Membership" CSHA members:

Weekend/Vacation home owners:

A weekly inspection of your vacation/weekend home and timely contact if something is amiss.

Permanent resident home owners:

Twice-weekly inspection of your permanent residence while you are on vacation, if requested. A weekly drive by inspection of your permanent residence.
