# **President's Report**

The Cascade Shores Homeowners Association (CSHA) continues to do well. We have 128 members as of 9/30/2023, an increase of 8 members from one year ago, and often have additional members join once cold weather sets in and people see that they can save up to 55% off their propane bill from non-member pricing. The money saved on one fill-up is usually enough to more than pay the annual homeowner's membership dues. Member numbers are very important, as maintaining and improving the Lost Mine Lake facility requires significant cash flow.

In addition to member dues, we have received donations of \$4,800 which included one large donation which paid almost the total cost of replacing our aging play structure. These donations help immensely in covering unexpected expenses throughout the year.

Thanks are also due to the many homeowners who have done a great job of improving the fire safety of their property. This work improves the safety of the entire community and helps maintain the Cascade Shores designation as a Firewise Community which in turn reduces homeowner insurance premiums.

The Board has again discussed the matter of our organization sponsoring social get-togethers. There is a lot of work involved in setting up those types of gatherings, and with continued poor attendance, the Board reiterated its opinion that doing such was not a worthwhile expenditure of effort or money. Our chartered reason for existing is to "hold, manage, operate and maintain certain property (Lost Mine Lake) --- and to take a public position on environmental and other matters affecting the quality of life in Cascade Shores and environs, etc."

### Treasurer's Corner Fall 2023

Opening fiscal-year cash balance at 4/1/2023 was \$3,440. Cash received through 9/30/2023 (six months of activity) totals \$22,495 (compared to budget of \$19,955) and includes basic and enhanced membership renewals of <u>\$16,735</u>, donations of <u>\$4,805</u> with an anonymous donation of \$2,300 designated for the new kid's play structure at Lost Mine Lake (LML), and LML rental and deposit fees of <u>\$955</u>.

Year-to-date (YTD) cash expenditures total \$14,755 and includes <u>\$6,465</u> related to LML with \$3,305 of that used for the cost of the play structure and the materials and labor necessary to install it. Another \$1,180 was spent on a second compressor needed for lake aeration, and \$1,980 was used for routine supplies and labor for lake upkeep. Additionally, <u>\$3,640</u> was spent on liability insurance, and <u>\$1,405</u> for utilities.

The balance of YTD expenditures pertains to administrative costs including home monitoring <u>\$1,500</u>, member outreach costs <u>\$500</u>, LML deposit refunds <u>\$200</u>, play structure social <u>\$170</u>, and office supplies, licenses, and FireSafe donation totaling <u>\$875</u>.

YTD cash expenditures represent 76% of our annual budget of \$19,505 with the play structure expense included, or 59% without the play structure. Remaining expected expenditures include renewal of Directors and Officer Liability insurance, six months of recurring expenses for home monitoring and utilities, fiscal year-end costs for mailing the Spring newsletter, and property taxes.

### Cascade Shores Gets Some Help From Nevada County

At the CSHA Annual Meeting concerns were raised with guest speaker Ricki Heck, Director of Division 1, Nevada Irrigation District, about NID property that abuts Lake Lane. Approximately three years ago the County arranged with a 3rd party contractor to clean and groom the adjacent land removing debris and turning the soil, making a clean fire break. After the last two years of storms the NID property was in disrepair and needed attention, and that any help with this would be appreciated. The board continued communication with Ricki and she responded that a contractor was going to the area to work on hazard trees. They worked within 100' of the property line, chipping dead and downed debris up to 15" diameter, as well as cut and chip all tree and debris under 8" diameter. The crew completed the project on August 31st. They worked for 2 days and did an excellent job.

The board also contacted Patrick Perkins, Principal Civil Engineer for Nevada County, after complaints about speeding in Cascade Shores. He replied that in the past year or so the County has completed studies in Cascade Shores resulting in placement of stop signs at several intersections. The speed limit within Cascade Shores remains at 25mph and they placed portable radar trailers at several locations to remind drivers of their speed throughout the summer. The County can bring the radar trailer out occasionally when requested. Speeding enforcement continues to be of concern and that requests for speeding enforcement should be directed to the CHP office in Grass Valley. So, the board needs your help, if speeding in Cascade Shores is a concern to you please contact the CHP. And you can rest assured that the board will continue to do so too!

### Dogs and Lost Mine Lake

Please remember dogs are only allowed on the trail around the lake and in the designated DOG BEACH area in the southeastern part of the lake. Dogs are not allowed in the pavilion, picnic table area or the beach area directly next to them. Poop bags are available at the lake for your use. It would be greatly appreciated if you would pick up after your dog.



### Home Monitoring Service

The home monitoring service provides weekly checks of your home to make sure that doors and windows are secure, and that no intrusion has been noted. The property is examined for trees or limbs that threaten the home, especially after a storm. Typically, we walk the perimeter of the home and onto decks for <u>vacation</u> monitoring or <u>unoccupied</u> home monitoring. If an irregularity is observed, we will contact the homeowner. If necessary, law enforcement will be contacted. With <u>occupied home</u> <u>monitoring</u>, or if you are here at your vacation home, we will view your home from the road but will not disturb you. Past notifications have included serious tree damage, water pipe rupture and garage doors left open to wildlife, or worse, intruders. During inclement weather we will do the best we can to access your property.

Please remember that this service is **NOT** a substitute for law enforcement. If you have issues or concerns about stolen mail, off-road vehicles being driven on residential streets, offensive noise from unruly neighbors, alarms going off at unoccupied homes, suspicious activity, dogs not on leashes, excessive speeding, or family issues of any kind please contact the appropriate Nevada County authority. They have the legal power to respond and act. Their phone numbers are:

If you are interested in the home monitoring service, check out the CSHA website: <u>www.cascadeshores.org</u> and click on the Home Monitoring Services link on the left side of the screen. The "Authorization for Home Monitoring Services" form is located there. Enhanced Membership is an affordable \$225 per year, which includes weekly monitoring of your home (April 1 to March 31, weather permitting).

We encourage all members of CSHA, whether participating in the home monitoring program or not, to join the Cascade Shores Homeowners Association FaceBook page. It's a great way to keep updated on critter sightings, *including snakes*, and other events, good and bad, going on in Cascade Shores. Another way to stay informed is to join the Cascade Shores Peeps FaceBook page which is open to everyone that lives in Cascade Shores. To increase police presence in our community, residents are encouraged to call law enforcement immediately whenever unlawful activity is observed. By doing so, law enforcement will have a documented record of occurrences that will support our need for more law enforcement presence in Cascade Shores.
