All garbage is to be placed in the dumpster, with no damages (including locks or gates), or missing items, from the kitchen, sports equipment, picnic or play areas. Please complete clean-up and return of the key within 24 hours of your event.

Cancellation Policy: Your deposit will be refunded if canceled at least 10 days prior to your event date. If cancellation is less than described here, your deposit is not refundable.

Rental Payment: Your rental payment, made payable to CSHA is due 7 days before your event date. If payment is not received, the reservation may be canceled by CSHA and the deposit retained.
